Minutes of the August 24, 2017 Meeting Small Water Systems Technical Assistance Center (TAC) Advisory Board

General Advisory Board business:

Three items of general business were introduced prior to new business:

- Robert Boos (replacing Brion Johnson) and Amy Batdorf (replacing E. Lee Koch) are acknowledged as the new members for PIIA and PMAA respectively. PIIA will need to appoint a new alternate.
- The October 26, 2017 meeting will be rescheduled for November 16, 2017.
- The draft minutes from the July 13, 2017 TAC Board meeting were presented for discussion. Lauren Gross (PAR) made a motion to approve the July 13, 2017 minutes as presented; Stan Brown (PUC) seconded the motion. The motion passed by a unanimous vote.

Public Comments

No comments were received from the members of the public in attendance.

TAC Board Discussion of draft Final-form Annex A - Disinfection Requirements Rule

Discussion continued on the draft final-form Annex A language and the informal comments received and distributed to TAC members/alternates.

- Mixing zones are dynamic and do not have discreet boundaries. Additionally, systems using chloramination that conduct free chlorine burns will also have mixing zones during the period of the free chlorine burn.
- Both free and total residuals would need to be reported for systems conducting a free chlorine burn; the higher value should be used for compliance determinations.
- The small system compliance monitoring should be kept at the weekly frequency. The Annex A language should clarify what data is reported & used for compliance if on-line analyzers are used for distribution system compliance monitoring.

TAC Board Comments on draft Final-Form Disinfection Requirements Rule

NOTE: Lauren Gross (PAR) and Mike Kelly were not present for this portion of the meeting. Therefore, there are 14 organizations counted in the voting on the following comments.

- Mary Roland made a motion that DEP should allow flexibility in the regulation for water systems to define
 the boundaries of mixing zones to account for dynamic operating conditions. The motion was seconded by
 Doug Crawshaw. However, the motion was withdrawn after the discussion (before a vote was recorded).
- Chip Bilger made a motion that DEP should modify the proposed language to identify whether the
 distribution system disinfection sample site is located within the mixing zone. The motion was seconded by
 Dennis Beck. The motion passed by a unanimous vote.
- Mary Roland made a motion that DEP should modify the distribution system disinfection language to
 address monitoring locations and compliance calculations for mixing zones and for chloraminating systems
 conducting a free chlorine burn. The motion was seconded by James Wheeler. The motion passed by a
 unanimous vote.
- Doug Crawshaw made a motion to keep the entry point chlorine residual level at 0.2 mg/L instead of the proposed 0.20 mg/L. The motion was seconded by Mary Roland. However, the motion was withdrawn after the discussion (before a vote was recorded).
- Chip Bilger made a motion that DEP should add language to clarify that multiple grab sample measurements
 from the same location during the monitoring period will be averaged by DEP into a monthly compliance
 value for that location. The motion was seconded by Mary Roland. The motion passed by a unanimous
 vote.
- Chip Bilger made a motion that water systems using continuous analyzers for distribution system
 disinfection residual measurements as described in their monitoring plan should calculate a daily average
 that is reported to the Department. The motion was seconded by Mary Roland. The motion passed by a
 unanimous vote.
- Chip Bilger made a motion that DEP should allow alternate compliance schedules (regarding the compliance
 date for the distribution system disinfection minimum level) to be approved in writing if the water supplier
 submits a written request with supporting documentation within 1 year after the effective date of the final
 rule. The motion was seconded by Mary Roland. The motion passed by a unanimous vote.
- Mary Roland made a motion that the distribution system disinfection level number should be changed to 0.1 mg/L from the 0.2 mg/L as originally recommended by TAC in July 2015. The motion was seconded by Larry Miller. The vote was recorded as follows:

- Sharon Fillmann made a motion that DEP should conduct a disinfection byproduct evaluation to determine the impacts of increasing the chlorine residual in the distribution system using data only from Pennsylvania water systems. The motion was seconded Mary Roland. The motion passed by a voice majority vote.
- Penny McCoy made a motion that DEP should retain the compliance calculations as proposed for water systems serving a population of 33,000 or less. The motion was seconded Dennis Beck. The motion passed by a voice majority vote (PBA voted No).
