### **Approval of Minutes –**

Approval of the draft minutes of the August 14, 2013, meeting was tabled for lack of a quorum.

### Review of Fees Established in 25 Pa Code Ch. 102 -

Jen Orr of the Bureau of Waterways Engineering and Wetlands presented a review of fees established in 25 Pa Code Ch. 102. These fees are related to National Pollutant Discharge Elimination System (NPDES) permits that are issued for the discharge of stormwater associated with construction activities. Ms. Orr fielded a number of questions from WRAC members, particularly with respect to how Conservation District funding relates to DEP's analysis of Chapter 102 permit fees. WRAC members also commented on projections indicating program surpluses into the next three fiscal years. Some WRAC members indicated such surpluses justified entertaining a reduction in fees. Conversely, other WRAC members questioned some of the assumptions underlying DEP's fee analysis, and believed the analysis underestimated program costs.

### Review of Fees Established in 25 Pa Code Ch. 92a -

Lee McDonnell, Director of the Bureau of Point and Non-Point Source Management presented a review of fees established in 25 Pa Code Ch. 92a. These fees are related to NPDES sewage, industrial waste, industrial stormwater, municipal stormwater, pesticide, aquaculture and agricultural permits. WRAC members asked questions regarding the presentation, which were addressed by Mr. McDonnell.

#### **General Discussion** –

Dr. Traver read aloud Article II of the By-Laws of WRAC and reminded the Committee of its role in providing technical advice to DEP. Dr. Traver underscored WRAC's ability to request and review policies, guidance or regulations of the Department.

#### **Public Comment Period –**
