# Purpose

- Regulatory changes required by EPA.
- Ensure Pennsylvania law allows DEP to request delegation of authority for applicable Federal Plans established by the EPA in 40 CFR Part 62.
- Clarify implementation of requirements for existing sources under 40 CFR Part 60.



# Background

- DEP historically submitted requests for delegation of Federal Plans to EPA citing 25 Pa. Code § 122.3 (relating to adoption of standards) as the express legal authority to do so.
- EPA indicated:
  - Language in 25 Pa. Code § 122.3 was insufficient.
  - DEP needed explicit language addressing adoption and incorporation by reference of Federal Plans.



# Background

- EPA establishes a Federal Plan in 40 CFR Part 62 to implement applicable emission guidelines established in 40 CFR Part 60.
- Federal Plans may be used by states that do not have an approved State Plan.
- States must request delegation of authority from the EPA to implement the Federal Plan if the state has subject sources in its jurisdiction and does not have an approved State Plan.

## Addition of §§ 122.4

- § 122.4 allows DEP to ask EPA for delegation of authority to implement an applicable Federal Plan established by EPA in 40 CFR Part 62.



# Public Comment Period

- The public comment period opened on June 21, 2025 and three public hearings were held:
  - July 22, 2025
  - July 24, 2025
  - July 29, 2025
- The public comment period closed on August 29, 2025.
- The IRRC comment period closed on September 29, 2025.



# Public Comments

- During the public comment period, the Board received comments from 22 commentators.
- Testimony from one witness was given at the public hearings.
- The Independent Regulatory Review Commission (IRRC) had comments.



# Public Comments

- IRRC and others asked how DEP evaluates various impacts of implementing Federal Plans in Pennsylvania.
- IRRC and others sought clarification about stakeholder input and consensus building when DEP requests delegation.
- Other comments were generally supportive of the rulemaking, expressed general concerns, or were outside the scope of the rulemaking.
- There are no changes to the regulation from the proposed regulation to final-form regulation.



# Public Comments

- All public comments can be found in their original form on the Department's eComment webpage as well as on the IRRC website (search on IRRC #3439). The Department prepared a Comment and Response document and final-form rulemaking documents that will be submitted to the Environmental Quality Board.



# Affected Parties

- Emission guidelines apply to the owner and operator of an existing facility in the covered source category.
- Applicable emission guidelines can be implemented and enforced by DEP either through:
  - An approved State Plan.
  - Delegation of authority to implement and enforce Federal Plan requirements.
