## Changes since the 2011 policy:

- Creation of the Non-Regulatory Agenda\*
- Enhanced Advisory Committee Consultation
- Administrative Changes

\*Recommendation of the Citizen's Advisory Council



# Non-Regulatory Agenda

- Development was a recommendation from the Citizen's Advisory Council.
- Similar to the Regulatory Agenda, will outline policies and Technical Guidance documents that are planned for updates over the next year.
- Will be published in the *Pennsylvania Bulletin* twice a year by February 1<sup>st</sup> and July 1<sup>st</sup>.
- The first Non-Regulatory Agenda will be published at the end of June.



# Policy Revisions - Enhancing Input

# **Enhanced Advisory Committee Consultation**

- Under the former policy, programs were asked to consider consultation with Advisory Committees.
- The new guidance enhances this process by requiring programs to explain how they engaged with Advisory Committees or explain why engagement was unnecessary or impractical.
- Programs are encouraged to consult with Advisory Committees as early in the development as possible.
