**New Business:**

**Chapter 93 – Proposal of Chloride Criteria**

Tom Barron ([tbarron@state.pa.us](mailto:tbarron@state.pa.us)), Bureau of Water Standards and Facility Regulation, provided a summary of the comments and changes resulting from those comments to the amendments. DEP is continuing to review the comments and scientific data and will return to WRAC with a final rulemaking before going to the EQB. No time line has been established as to when this final rulemaking will go before the EQB.

**Chapter 93 – Triennial Review of Water Quality Standards**

Tom Barron gave a presentation on DEP's undertaking of the Triennial Review of Water Quality Standards and asked for any recommendations that DEP should consider in the Review. It is DEP's hope to have the Review back before WRAC in early 2011.

**Chapter 105 (Fees)**

Tom Bold ([tbold@state.pa.us](mailto:tbold@state.pa.us)), Bureau of Waterways Engineering, Roger Adams ([roadams@state.pa.us](mailto:roadams@state.pa.us)), Bureau of Waterways Engineering, and Sid Freyermuth ([sfreyermuth@state.pa.us](mailto:sfreyermuth@state.pa.us)), Bureau of Watershed Management, answered questions on the language updating the fees in Chapter 105. In light of discussions, a motion was made to move this regulation forward while also asking that the Department consider modifying the proposed rule before submission to the EQB to incorporate flexibility in the fee structure to accommodate multiple structures in one project. This motion was passed unanimously.

**Chapter 105 (Dam Safety)**

Tom Bold and Roger Adams highlighted proposed changes to the Dam Safety portion of Chapter 105.

A motion to move this package to the EQB with clarification on the Professional Engineer requirement (in Section 105.102(b)) was approved by unanimous vote.
