Statutory Requirements

Radiation Protection Act

Act 1984-147 (as amended by Act 2014-190)

"...set reasonable annual fees for the registration of radiation sources and the licensing of radiation source users."

Radon Certification Act

Act 43-1987

"...establish a fee schedule to cover the costs of certification"


Reason & Purpose for Proposed Fees

- The fees from radiation-producing machine and radioactive material users, and radon testers, mitigators and laboratories are the sole source of revenue for their respective programs.
- The last fee increase was 7 years ago, with program and personnel costs having increased approximately 45%.
- With the exception of the radiation-producing machines program area, which needs no fee increase at this time, current fees will be unable to fully support the radioactive materials and radon programs.
- This proposed fee rulemaking will provide revenue sufficient to cover program costs, as directed by Act-147 and Act-43.



Current RAM Fees


RAM – Available Revenue and Expenditures (in \$1,000) -- No Increase

Summary and Recommendations


A new Radon Mitigation System "Tag" fee is proposed:

- \$50 fee for each mitigation system installation
- 8,000 10,000 installations each year at a cost of \$500 \$2,000 each
- Expected to generate needed revenue to support program activities
- Similar radon system fees have been successfully implemented in other states:
 - Iowa (1989)
 - Nebraska (2003)
 - Illinois (2009)
 - New Jersey (2010)


Note: we estimate this new fee represents ~5% increase to the consumer.

Summary

- The proposed rulemaking would take effect upon final-form publication in the *Pennsylvania Bulletin*.
- The revised fees would be applied to all new applications received after the effective date of the rulemaking.
- Renewal notices sent after the effective date of the rulemaking will include the revised fees.



Summary

- October 16, 2014, the Radiation Protection Advisory Committee (RPAC) approved the Proposed Rule.
- The Board reviewed our Fee Analysis in late 2014.
- DEP respectfully requests that the Board approve this proposed fee rulemaking.
- DEP recommends a 60-day public comment period.
