Statutory Authority

- Noncoal Surface Mining Conservation and Reclamation Act
- Clean Streams Law
- Administrative Code of 1929



Purpose

- Adjust Fees to improve DEP's ability to cover the cost of implementing the Noncoal Surface Mining Conservation and Reclamation Act.
- Reviewing, administering, and enforcing permits.



Activities Funded by Fees

- Review of permit applications and modifications
- Inspections of mining sites
- Compliance activities



Background

- Fees most recently changed in 2012
 - Permit Application Fees
 - Annual Administration Fees
- Three-year fee report provided in May 2015
- Aggregate Advisory Board
 - Established in 2014
 - Initial Meeting May 2015
- The proposed rulemaking was adopted by the EQB in October 2017



Three-Year Fee Report

- Identified three factors why fees were insufficient:
 - Based on 2009 wage rate
 - Increased Benefit rate
 - Fewer Applications
- FY 2017-18 program shortage = \$972,000



Aggregate Advisory Board

- Six Board Meetings
- Seven committee meetings
- Extensive program revenue and cost data was reviewed
- In August 2016, the Aggregate Advisory Board recommended that the Department proceed with the rulemaking process



Final Rulemaking

- Phases in fee increases in three 2-year steps:
 - Step one adjusts fees for current wage costs
 - Step two adds indirect costs
 - Step three adds overhead costs
- After this, adjusts fees every two years based on the U.S. Department of Labor Employment Cost Index related to state and local government workers
