
To the Board:

This is to advise you on behalf of our client, Waste Management Disposal Services of Pennsylvania, Inc. (WMDSP), that they have no objection to the Department of Environmental Protection's Report to the Environmental Quality Board Concerning the Rulemaking Petition Submitted by WMDSP on December 17, 2008 to Amend the Existing Hazardous Waste Listing Exclusion for the sludge filter cake generated at the WMDSP Morrisville wastewater treatment plant.

We have asked the Department that, in the event that the EQB approves the delisting as recommended in the Report, we would appreciate anything that can be done to place the proposed rulemaking before the Board for action earlier than late summer or early fall 2009 as contemplated in the Report. WMDSP is approaching the 2000 cy annual limit so that amendment of that limit as proposed in the Report takes on added importance.
