Notice of Public Comment Period and Hearing: Prompt-Interim Response for Benner Township PFAS Investigation

The Pennsylvania Department of Environmental Protection (DEP), under the authority of the Hazardous Sites Cleanup Act (HSCA), has initiated a Prompt-Interim Response for the Benner Township PFAS Investigation (Centre County). The area of investigation surrounds the University Park Airport and includes a commercial/industrial area to the north and mixed residential/agricultural areas primarily to the east and south.

The investigation was initiated after PFAS compounds were detected in the public water supply well serving the State-of-the-Art company located on High Tech Road. The HSCA-funded investigation is focused on defining the extent of the plume, identifying any receptors, and determining the source(s) of the contamination. PFAS consists of a number of man-made compounds manufactured for industrial and household uses. PFAS is present in a wide variety of products and is ubiquitous in the environment. Several PFAS compounds are known to cause potential damage to human health.

The focus of DEP's investigation to date has been concentrated on sampling pri-

The focus of DEP's investigation to date has been concentrated on sampling private water supply wells in the areas of known contamination to identify any residents exposed to PFAS levels above the EPA lifetime Health Advisory Level (HAL) of 70 parts per trillion. Property owners whose wells contained PFAS above the EPA HAL and who did not have an existing home treatment system that effectively treats PFAS have been provided with bottled water for consumptive use as a temporary Prompt Interim Response due to the exposure of residents ingesting a harmful chemical.

DEP intends to install home water treatment systems for residential wells that do not have existing effective treatment and exceed the HAL as part of this Prompt Interim Response to better address other potential exposure pathways. An analysis of alternatives will be conducted to determine a final remedy; these may include a permanent alternate water supply, such as installation of and hook-up to a public water line extension, and the permanent operation of the home treatment systems.

This notice is provided pursuant to Section 506(b) of HSCA.
