Dear Mr. White:

This letter serves as notification that the Pennsylvania Department of Environmental Protection (Department) has investigated the West Lebanon Groundwater Site (Site) located along Union Canal Drive in Lebanon County, Pennsylvania, and has determined that response action is appropriate. Pursuant to Section 501(a) of the Pennsylvania Hazardous Sites Cleanup Act (HSCA), Act of October 18, 1988 (P.L. 756, No. 108, 35 P.S. §§ 6020.501(a), the Department is required to notify the owner, operator, or other known responsible persons when the Department determines that response is appropriate pursuant to HSCA.

The Department has determined that perchloroethylene (PCE) contaminated groundwater exceeds the Maximum Contaminant Level (MCL) for public water supplies. Contaminated soils exceed the Medium-Specific Concentrations for State Wide Health soil to groundwater numeric values for PCE. Therefore, threats to human health and the environment and the migration of PCE to groundwater exist at the site.

Our information indicates that you may be a responsible person under Section 701 of HSCA, 35 P.S. §§ 6020.701, with regard to this Site. Therefore, you could be responsible under state law for the cost or performance of any environmental investigations or cleanup actions required at this Site. Pursuant to Section 506(b)(2) of HSCA, 35 P.S. § 6020.506(b)(2), the Department is providing you with a copy of the notice that will be published in the *Pennsylvania Bulletin* for the prompt interim action of an interconnection with the City of Lebanon, carbon treatment for the West Lebanon Municipal Supply Well #2, and to remove and dispose of contaminated soil. Further investigation to determine the extent of soil and groundwater contamination will be conducted to determine if additional response actions are necessary.


