Hi Rock,

My apologies for not getting back with you earlier about this. I no longer work at the SHPO, my last day there was the day before Thanksgiving. I now work at PennDOT as one of their District archaeologists. Please contact Doug McLearen for official comment on this issue.

That said, I'll still give my two cents anyway since I was involved in the project. Archaeological survey was undertaken for this project in two efforts and no evidence of the Confederate retreat from Gettysburg (or the Northern pursuit of the retreating Confederate Armies) was found or uncovered in the project area (which is to say, within the area of potential effect). A post Civil War (late 19th/20th) century residential foundation was recorded in the project area as was the exploratory copper mine, neither of which have anything to do with the Civil War. This is not to say that Civil War solders didn't march south through this area after Gettysburg, but there is no physical evidence of this recovered from the project area (area of potential effect) as a result of the archaeological survey undertaken. The people who did the work for this project are good archaeologists and the survey was well done. Any further comment should come from Doug.

Doug, my apologies for stepping out of place here a little bit. I don't want to step on your toes.

The Pennsylvania State Historic Preservation Office (PA SHPO) has reviewed the above named project as per the Commonwealth of Pennsylvania Notification of Sub-grant between the Department of Environmental Protection and the Pennsylvania Historical and Museum Commission Regarding the Regulation of Coal and Non-Coal Mining within the Commonwealth (authorization Public 95-97, Surface Mining Control and Reclamation Act of 1977). Based on an evaluation by our staff, including the results of the field visit by Steve McDougal of our office on 9 August 2017, and as stated in correspondence to Specialty Granules, LLC. These resources could be adversely affected by project activities. It is our opinion that a Phase I archaeological survey should be conducted to locate potentially significant resources.
