Dear Mr. Armstrong:

This letter constitutes the response of Whittaker Corporation ("Whittaker") to the request of the Pennsylvania Department of Environmental Protection ("PDEP") for information concerning the release and/or threat of release of hazardous substances into the environment from the above-referenced site. Based on a telephone conversation with Mr. Sheehan of your office this week, it is our understanding that TCE has been detected at or in the vicinity of the Site and in local groundwater. The Department's letter to Whittaker was misdirected due to the fact that Whittaker has not been involved with this Site for the past thirty years, as set forth more fully below.

Through its subsidiary, Whittaker Enterprises, Inc., Whittaker acquired Bishop Tube Co. from Matthey Bishop, Inc., a Johnson Matthey affiliate, on or about February 28, 1969. Pursuant to an Agreement of Purchase and Sale, dated November 25, 1973, between Whittaker and the Central and Western Chester County Industrial Development Authority ("Authority"), Whittaker sold to the Authority (i) all of the real property together with all improvements located thereon of the former Bishop Tube facility, which we assume comprises some or all of the Site in East Whiteland Township, and (ii) all of the machinery, equipment, tooling and other depreciable assets located on the real property and used in the business of Bishop Tube ("Equipment"). Copies of the Deed and the General Bill of Sale and Assignment from Whittaker to the Authority are enclosed as Exhibits "A" and "B," respectively.

Concurrent with the transfer of the Site to the Authority in 1973, Whittaker sold to Christiana Metals Corporation ("Christiana") all of the remaining assets of the business conducted at the Site, including all raw materials, work in progress and finished goods, goodwill, and, in particular, all of the books and records of the business. A copy of the General Bill of Sale and

Assignment from Whittaker to Christiana, dated January 7, 1974, is attached as Exhibit "C". The Bill of Sale states, in pertinent part, that Whittaker transferred and delivered to Christiana "[a]ll of the books and records, correspondence, plans, drawings, designs, patterns, production records, employment records, files with respect to inventions, laboratory and testing records, formulae, inventions, trade secrets and other confidential information, related to the business...."

The Authority and Christiana entered into two Installment Sale Agreements, dated as of January 7, 1974, providing for (a) Christiana's purchase of the real property and improvements on the Site and the Equipment after payment of the purchase price over a 20-year period, and (b) the Authority's ownership of the real property and improvements, plant and Equipment at the Site during this 20-year period.

Whittaker has conducted a diligent search of it records archives for any and all documents related to hazardous substance and/or waste usage and disposal at the Site. None of those records have been located, except as set forth herein. Based on the terms of the above-referenced agreements and the absence of such records in Whittaker's archives, it appears that all operational records were transferred to Christiana and/or the Authority in connection with Whittaker's sale in late 1973.

We respond specifically to your requests for information as follows;

1. "Documentation regarding the types and quantities of hazardous substances, or materials containing hazardous substances which were disposed of, stored, treated, spilled or released into the soil, groundwater or surface water at the Site."

Response: Attached as Exhibit "D" is a copy of an unsigned Consent Order, dated September 24, 1974, between the Pennsylvania Department of Environmental Resources and Christiana. Whittaker also possesses two privileged memoranda to and from an attorney in its legal department, dated September 14 and 17, 1973, prepared in connection with the sale. While we cannot reveal the specific contents of these memoranda without waiver of the privileges for attorney-client communications and attorney work product, we represent to you that the subject matter of the memoranda concerns release of acid into the environment. We further represent to you that neither of these memoranda refers to TCE, any solvents or any other hazardous substances, and that the type of acid released is not identified in the memoranda. We also represent to you that one of these memoranda indicates that an environmental consultant's report was submitted to the Department of Environmental Resources concerning possible corrective actions to address this acid release in or around June 1973. Whittaker does not possess a copy of the subject report.

<u>Response</u>: Whittaker does not possess any documentation responsive to this request other than the documents referenced hereinabove.

3. "Documentation concerning how such hazardous substances or materials containing hazardous substances were treated, transported to, stored or disposed of at the Site."

<u>Response</u>: Whittaker does not possess any documentation responsive to this request other than the documents referenced hereinabove.

4. "Documentation regarding the identity and address of any other person or company which generated, treated, stored, transported or disposed of hazardous substances or materials containing hazardous substances at the Site."

Response: As indicated above, other owners or operators of Bishop Tube Co. and/or the Site are believed to be:

5. "Documentation regarding the assets and liabilities of Whittaker Corporation."

Response: Whittaker is an indirect, wholly-owned subsidiary of Meggitt-USA, Inc., and, as such, does not maintain separate financial statements. The audited financial statements of Meggitt-USA, Inc. are not publicly available, contain confidential business information, and the release of such sensitive information is made only under confidentiality protections. Please advise whether the PDEP would designate the Meggitt-USA, Inc. financial statements as confidential, and we will provide them accordingly.

It is Whittaker's policy and practice to cooperate with environmental authorities in the investigation and remediation of hazardous substances released into the environment by Whittaker. While we have no documentation at the present time that Whittaker used or disposed of TCE at this Site, we will cooperate fully with PDEP in its investigation and determination of whether such releases may have occurred during Whittaker's ownership and/or operations at the Site.

As discussed with Mr. Sheehan of your office this week, Whittaker has no information respecting the investigation and/or remediation activities at this Site for hazardous substances, other than Mr. Sheehan's informing us that there has been TCE detected in groundwater located at or adjacent to the Site. Accordingly, we have requested the environmental consulting firm Scientech to contact your office in order to review the files available for the Site. We also request to speak to you either in person or by conference call with our consultants to get a better understanding of the background and scope of the Site's environmental conditions and your investigation. Please let me know if such a meeting or conference call may be arranged. My direct dial is 805-526-5700, extension 6650.

Please do not hesitate to call if you have any questions, comments or requests for further information from Whittaker. All communications regarding this matter should be directed to my attention. Nothing herein is or should be deemed a waiver of any of Whittaker's rights and/or remedies respecting this matter, all of which are expressly reserved.

CONSENT ORDER

WHEREAS, a precision metal tube manufacturing facility located at Frazer, Chester County, Pennsylvania, has utilized for many years Valley Creek, part of the waters of the Commonwealth, for the discharge of its industrial waste; and

WHEREAS, the nature of the waste being discharged has been such as to be potentially hazardous to the public and to require a permit pursuant to the provisions of the Pennsylvania Clear Stream Law; and

whereas, this manufacturing facility has engaged over an unknown period of years in various processes harmful to the Commonwealth's environment and to its said waters, namely discharge of industrial wastes into its septic system, the temporary storage of industrial waste in a "wet well" and the collection and discharge into its sanitation system of waters threatening flooding conditions to its plant; and

WHEREAS, the nature of the violations over the years has been such as to create a certain fixed financial responsibility on the operator of the facility to the Pennsylvania Clear Water Fund; and

WHEREAS, the present operator has proposed such steps to eliminate the pollution of the said Valley Creek in such manner and within such time period as to justify a reduction of a continuing monthly obligation to the said Fund; and

WHEREAS, the present operator of the facility is Christiana
Metals Corporation, a Pennsylvania Corporation, doing business at Frazer,
Pennsylvania as Bishop Tube Company ("Bishop Tube").

whereas, neither Bishop Tube or its predecessors
have applied for nor have they been issued a permit pursuant
to the provisions of the Pennsylvania Clean Streams Law, by
the Commonwealth of Pennsylvania, Department of Environmental
Resources ("Department") to discharge or permit the discharge
of industrial waste to the waters of the Commonwealth.

NOW THEREFORE, on this 24th day of September,

1974, it is hereby agreed by the Department and Bishop Tube
that:

, **66**61 | 6661 | 1176 After full and complete negotiations of all matters set forth in this Consent Order, both the Department and Bishop Tube, upon mutual exchange of convenants herein and intending to be legally bound by this Consent Order agree as follows:

- I. On or before May 1, 1975, Bishop Tube shall cease and desist all discharges to the waters of the Commonwealth.
- II. Bishop Tube may continue to discharge

 its sanitary wastes to the existing septic system;

 provided, said sanitary wastes are disinfected by

 the application of chlorine. When connection to

 the East Whiteland sewerage system becomes avail
 able, Bishop Tube shall connect to said system

 and cease and desist all discharge of sanitary

 wastes to the septic system.
- III. Bishop Tube shall dispose of all solid and acid wastes in a method approved by this Department.
- Tube shall aubmit to the Department, for approval, a "conceptual report" regarding the methods to be employed for eliminating all discharges as required by paragraph I above; and a pollution incident prevention program ("PIPP") in accordance with the written instructions given Bishop Tube by the Department during their September 24, 1974 meeting.

Bishop Tube shall, commencing with the month of October, 1974, on or before the 15th day of the subsequent month, submit to the Department's Norristown Office, monthly progress reports, including, inter alia, information on the availability of equipment, materials, and energy requirements until such time as Bishop Tube is notified, in writing, by the Department, that it is in compliance with this Consent Order. Further, within ten(10) days of any delay or notice of said delay, whichever occurs first, affecting its ability to comply with this Consent Order, Bishop Tube shall, by certified mail, notify the Department's Norristown Office of such delay and the reasons therefore. All monthly progress reports and reports of delays shall be accompanied by a notarized, verifying affidavit, executed by the President of Bishop Tube.

terms of paragraph I above of this Consent Order and such failure is caused solely by revolution or other civil disorders, wars, acts of enemies, strikes, lock-outs by other than Bishop Tube, floods, acts of God, unavailability of equipment and/or material or other causes not within the control of Bishop Tube, which Bishop Tube, by exercising reasonable diligence, would not be able to prevent, the Commonwealth will not institute any civil or equitable proceedings, provided notice is given the Department as set forth in paragraph V above.

VII. Contemporaneous with the execution of Consent Order, Bishop Tube shall voluntarily contribute Ten-Thousand Dollars (\$10,000) to the Pennsylvania Clean Water Fund, in lieu of civil prosecution for past violations of the Pennsylvania Clean Streams Law.

VIII. Should, for any reason, compliance with paragraph I above be delayed beyond May 1, 1975, Bishop Tube shall voluntarily contribute Two-Thousand Dollars (\$2,000) to the Pennsylvania Clean Water Fund per month until the provisions of paragraph I above are complied with. Payment of voluntary contributions under this paragraph are to be made with the monthly progress reports as provided for in paragraph V above, provided in no event, shall compliance with paragraph I be delayed beyond August 1, 1975, except as provided for in paragraph VI above.

appeal Orders of the Department, hereby waives its right to appeal from this Consent Order. This Consent Order shall have the force and effect of an order issued by the Department pursuant to its authority under the Pennsylvania Clean Streams Law and shall be enforceable as a final order of the Department.

To enforce this Consent Order and any violation of the Pennsylvania Clean Streams Law and the Rules and Regulations of the Environmental Quality Board promulgated pursuant thereto except those exclusively waived in this Consent Order; the Department shall not institute any civil action to obtain compliance with the Pennsylvania Clean Streams Law and the Rules and Regulations of the Environmental Quality Board promulgated pursuant thereto so long as and Bishop Tube complies with this Consent Order. All rights and remedies contained herein are to be concurrent, unless specifically provided to the contrary.

II. This Consent Order shall bind the parties, their agents, servants, employees, successors and assigns.

XII. This is the entire agreement between the parties and no alterations, additions or amendments thereto shall be valid unless in writing and duly executed by the parties.
