Intent to Issue a Plan Approval and Intent to Issue or Amend an Operating Permit Plan Approval No. 23-0004B Delaware County

Notice is hereby given in accordance with 25 Pa. Code Sections 127.44(b), 127.424(b), 127.462(c) and 127.521 that the Department of Environmental Protection (DEP) intends to issue Plan Approval No. 23-0004B to Covanta Delaware Valley, L.P. (Covanta) - Delaware Valley Resource Recovery facility (DVRRF) located in Chester City, Delaware County. This Covanta facility is located at 10 Highland Avenue, Chester, PA 19013.

On November 11, 2022, the "Additional RACT requirements for major sources of nitrogen oxides (NOx) and volatile organic compounds (VOCs) for the 2015 Ozone NAAQS" of 25 Pa. Code §§129.111 -129.115 (reference 52 Pa. Bulletin 6960), commonly referred as RACT III requirements were finalized and effective. The RACT III incorporates provisions and requirements for the control of emissions of NOx and/or VOCs. These provisions and requirements are intended to address the Commonwealth's RACT obligations under section 184 of the Clean Air Act for the 2015 8-hour ozone National Ambient Air Quality Standards. Covanta is subject to the applicable RACT III requirements, pertaining to NOx emissions, and is not subject to the RACT III requirements pertaining to VOCs emissions as its potential-to-emit VOCs emissions are less than 50 tons per year.

Plan Approval No. 23-0004B is for the installation of one (1) unit of aqueous ammonia Selective Non-Catalytic Reduction (SNCR) system on each of the municipal waste combustors [a total of six (6) units of SNCR systems] at this waste-to-energy plant, which incinerates residual waste and municipal waste and generates 90 net megawatts of electricity per hour, in order to meet the RACT III NOx emission limitation of 110 ppmvd, corrected at 7% oxygen, as defined in 25 Pa. Code § 129.112(f). There are no proposed changes to potential emissions and process operations of the facility. Therefore, this project is not subject to New Source Review and Prevention of Significant Deterioration Review. The proposed plan approval incorporates applicable requirements of the RACT III rules pertaining to Nitrogen Oxides (NOx) emissions, monitoring, recordkeeping and reporting.

The facility is currently operating under Title V Operating Permit No. 23-00004. Emission sources at the facility consist of six (6) municipal waste combustors and their associated processing and emission control devices, one (1) cooling tower, one (1) emergency generator diesel engine, one (1) fire pump engine, and two (2) cold degreasers. The facility is a major stationary source as defined in Title I, Part D of the Clean Air Act Amendments. The facility is therefore subject to the Title V permitting requirements adopted in 25 Pa. Code, Chapter 127, Subchapter G. It is also subject to the State Plan for Large Municipal Waste Combustors approved by the USEPA (effective on October 4, 2001; 66 FR 43509). The Plan Approval No. 23-0004B will subsequently be incorporated into the Title V Operating Permit No. 23-00004 through an administrative amendment in accordance with 25 Pa. Code Section 127.450.

Copies of the plan approval application, the proposed plan approval, and other relevant information are available for public review at DEP's Southeast Regional Office, 2 East Main Street, Norristown, PA 19401 or on the Southeast Community website at https://www.dep.pa.gov/About/Regional/SoutheastRegion/Community%20Information/Pages/Covanta.aspx. An appointment to review the documents may be scheduled by calling the Records Management Section of DEP's Southeast Regional Office at 484.250.5910 between 8:00 A.M. and 4:00 P.M., Monday through Friday, except holidays.

A public comment period, beginning April 15, 2023, and ending May 27, 2023 (10 days after the public hearing), will exist for the submission of written comments, suggestions, objections, or other information regarding the proposed Plan Approval. Submissions may be made in writing to Ms. Janine Tulloch-Reid, P.E., Environmental Engineer Manager, Facilities Permitting Section, Pennsylvania Department of Environmental Protection, Southeast Regional Office, 2 East Main Street, Norristown, PA 19401, or electronically at ra-epseroaqpubcom@pa.gov. Each submission must contain the name, address, and telephone number of the person(s) submitting the comments, identification of the proposed Plan Approval and condition number(s), and a concise statement regarding the relevancy of the information or objections to issuance of the proposed Plan Approval.

A public hearing is scheduled to be held on May 17, 2023, from 6:30 P.M. to 8:30 P.M., at the Chester City Hall (Chester City Municipal Building), 1 E 4th St, Chester, PA 19013. Persons wishing to present testimony at the hearing should contact Ms. Stephanie Berardi, Community Relations Coordinator, at sberardi@pa.gov or 484.250.5808 to register by May 16, 2023. Individuals who do not register may also present testimony the day of the hearing. Oral testimony will be limited to 3 minutes per individual, and time may not be relinquished to others. Each organization is requested to designate one witness to present testimony on its behalf. A stenographer will be present to record the testimony; copies of remarks are requested to aid in the transcription of comments. All comments, whether submitted to DEP in writing or delivered orally at the hearing, shall merit equal consideration.

Persons unable to attend the hearing may submit a written statement and exhibits by May 27, 2023, to Mr. James D. Rebarchak, Environmental Program Manager, Pennsylvania Department of Environmental Protection, Southeast Regional Office, 2 East Main Street, Norristown, PA 19401, or electronically at ra-epseroaqpubcom@pa.gov.

Should inclement weather postpone the hearing date, this information will be posted at the above web address. Please contact Ms. Stephanie Berardi or monitor DEP website to determine if a hearing will be held.
