Township**

Dear Mr. Mountain:

Pursuant to your direction, Richard E. Pierson Material Corporation (“RE Pierson”) is hereby submitting this abatement plan to detail the actions that will be taken to remain in compliance with all applicable air quality control regulations related to the construction of a 1000 ton per hour stone crushing and screening plant equipped with a wet suppression system to be located at 2205 North Rockhill Road, Sellersville, PA 18960, Bucks County, East Rockhill Township.

RE Pierson has implemented the following actions to address the above referenced NOV and to remain in compliance with the applicable regulations:

- (1) RE Pierson has ceased all construction of any foundations and/or structural steel associated with the proposed permanent non-metallic mineral crusher and screening plant as referenced in the Department’s May 24, 2018 NOV.
- (2) RE Pierson has suspended the delivery of the proposed primary crusher plant to the facility. In addition, RE Pierson will not take any future deliveries of any dedicated equipment associated with the proposed crusher facility until a Plan Approval has been issued by the DEP, or the Department concurs that the equipment is not subject to the Plan Approval provisions.


