Re: REPA is not alone in request for PERMANENT CLOSURE of the ROCKHILL QUARRY

In recent months, calls have been growing to Governor Wolf, PADEP and PA Department of Health from legislators, environmental groups and residents asking for the permanent closure of the Rockhill Quarry in East Rockhill Township due to the presence of Naturally Occurring Asbestos (NOA).

In a letter written to Rockhill Environmental Preservation Alliance (REPA) on February 7, 2020, the PA Department of Health shared that the NOA at the Rockhill Quarry site “should be avoided and left alone” and that it would be detrimental to the health and wellbeing of the residents if it were to be disturbed in any way.” PA DOH further states: “Avoid blasting it, crushing it, or grinding it up. . . Especially avoid digging, transporting and/or gardening in areas in which NOA has been detected or suspected to be present.” REPA's expert geologist, Dr. Bradley Erskine, has issued several reports indicating that results to date have severely under reported asbestos levels, and that the methodologies for test results submitted

to DEP by Hanson Aggregates PA, LLC have not been in conformance with universally recognized standards of practice for asbestos testing.

REPA requests that you closely review the letters we are enclosing, as well as all of the technical reports we have previously submitted to PADEP. All reports can be found on the REPA website.

We strongly urge that PADEP do the right thing and, together with Governor Wolf and the PA Department of Health, respond to the concerns of legislators and environmentalists, as well as the community which you are tasked to protect and who will be put at risk for exposure to a deadly carcinogen should operations at the Rockhill Quarry be allowed to resume.
