Narrative:								
DEP personnel Olivia Budnovitch, Tim Cherry, and Simon Mullen arrived at the Washington Crossing neighborhood at 10:07 to conduct sampling of residential potable wells. DEP met with Mike Mcdonough (GES), Jeff Plummer (GES), and Johnathan Brandon (CTEH) at 124 Walker Road. The upstairs kitchen faucet was purged for 10 minutes from 10:10 to 10:20. GES conducted their sampling from 10:20 to 10:48 which included dissolved lead and VOCs from both the influent and effluent ports. They also collected a jar of water from both the effluent and influent ports and allowed it to sit for 15 minutes before taking a PID reading. PID readings after 15 minutes were 0.0ppm. After conducting their sampling, GES moved to the backyard to open the potable well head. GES then put a bailer down the well to detect any odors or product. No odors or product were observed. They also collected a jar of water which they let sit for 15 minutes before taking a PID reading, which was 0.0ppm after the volatilization time. No samples were collected directly from the well. DEP conducted sampling from 10:48 to 11:03. We collected VOC samples and total lead. Samples were collected from the influent "raw" water port between the first sediment filter and the first carbon tank. This was the closest point to the water tank where samples could be collected. No odors were observed in the water. Samples were collected in accordance with the Sampling Analysis Plan (SAP). The treatment system in the home included three carbon tanks, a UV system, and a water softener (Picture 1 &2). Samples were placed immediately on ice and DEP departed the residence at 11:04. DEP arrived at 102 Spencer Road at 11:07. GES did not split samples at this residence. Water was purged from the upstairs kitchen faucet for 10 minutes from 11:11 to 11:21. Samples were collected from the spigot on the water pressure tank before going through any sediment filters, carbon filters, acid base neutralizers, or water softeners. We noted that the port labeled "raw" was after the acid base								
treatment system in Picture 3 included two carbon tanks, a water softener, an acid base neutralizer, a UV system, and reverse osmosis. DEP departed the residence at 11:40 and headed back to the office.
