We arrived at 108 Spencer Road at 9:48 to observe the recovery well that was being installed. Joe and Nancy from ET were already on site. GES was at 107 Spencer Road gauging the water at the wellhead. They took a PID reading, checked the depth to water, and used a bailer to determine if there was any LNAPL present. There was no PID reading, no odor, and no LNAPL present. They stated that they had performed the first gauging event at 128 Walker Road at 9:07. The initial LNAPL that was present measured at 0.12 feet and a PID reading of 360ppm. After bailing the LNAPL, the measurement was 0.01 feet. All the bailed water/LNAPL was placed in a Home Depot bucket with a lid. They stated that they were going to gauge the wellhead at 105 Spencer Road.

The sonic drill rig was already up and operating. The company installing the well was Paratt and Wolff. I observed an area next to the driveway which was lined with plastic with pallets in it. This was the storage area for the drums after they will filled. There was a vacuum truck there from Lewis Environmental. Wassem showed me around the property, where I observed three air monitoring stations: one on each side and one in the front yard on the other side of the sound panels at 108 Spencer Road. I spoke with an employee of CTEH who oversaw monitoring the air and sound around the property while the recovery well was being drilled. He stated that the canisters collecting the air samples were set for a 24-hour period, then they would be switched out and sent to Pace to be analyzed. There were two employees from CTEH who were monitoring around 108 Spencer Road. They had a PID to measure any potential vapors not close to the canisters and a sound meter to monitor the noise level from the drill rig.

I went and looked at the drilling of the recovery well. The goal for the day was to drill to 20-25 feet bgs, then set the casing and come back the following day to drill to the chosen depth of 70-feet bgs. There was an area lined with plastic that was set up around the drill rig to capture the liquid from the drilling. I observed two cores being removed from the drill rig. Each time the water was vacuumed to the truck from Lewis. Dan was the P.G. on site from GES to screen and log the cores recovered from installing the recovery well. I asked where the second recovery well was going to be installed, and he replied that only one was going to be installed based on the results of the packer test and geophysics of the potable well. He had not noticed any elevated PID readings or odors in the cores down to 10-feet bgs.


