Dear Ms. Paluh:

We received your letter dated July 28th, 2016 regarding a request for information on former Westinghouse Electric Corporation facility operations. As the agency is aware, Eaton is the current owner of the former Westinghouse site located at One Tuscarawas Rd, Vanport Township, Beaver, PA., having acquired the same in 1994.

With respect to your questions, we have conducted a good faith review of available information. Our responses are below:

1. With regards to operations conducted at the former Westinghouse facility, as the agency knows, CBS Corporation has responsibility and ownership of the remediation system which includes permits under their name. CBS conducts their own monitoring and reports their own results. We understand from your letter that you are not seeking production of any records or information associated with that system. However, to the extent the agency has outstanding questions on that system, or any hazardous substances associated with that system or used during the Westinghouse operations, we request that further inquiries on the same be directed to Mr. William Wall, CBS Corporation's legal counsel who we have cc'd below.
2. With respect to post-1994 Eaton operations, please note hazardous substances are not and have not been treated, disposed of or released on-site, nor any associated wastes. Hazardous substance handling and management, including any emissions thereof, are authorized by our discharge permits with the state. Those permits include a PADEP Certificate of Registration for x-ray equipment, NPDES Permit and a Natural Minor Operating Air Permit.

3. As to hazardous substances used/stored at the facility in current operations (types/approximate quantities beyond insignificant amounts), they are as follows, Sulfuric Acid for pH adjustment of wastewater and contained in fork truck batteries (24,750 lbs.), Petroleum Oil (166,000 lbs.), Sodium Hypochlorite used to treat pond for algae (300 gallon tote) and we are a small quantity generator of hazardous waste (TPC nonchlorinated degreaser, paint thinner, Silver Cyanide solution, biohazard medical waste); copies of the relevant SDS sheets are available upon request.

Finally, please note that I am the new site contact replacing Ted Kasper as of April 1st, 2015.
