Attached is an approval letter from the Vanport Municipal Authority concerning the installation of the sloped overlay to the pump room floor at the Stripping Towers. This work should be scheduled for late fall, when the heating system is on and condensation on the piping is reduced. This will allow the work to proceed in relatively dry conditions.

As far as the installation being performed by a Sika licensed applicator, I think that is a good idea if you subcontract the work, but if you elect to do the work with your people, I will discuss that with the Authority.


Dear Mr. Farland:
