Dear Ms. Paluh:

We represent CBS Corporation in connection with the Department of Environmental Protection's ("Department") July 28, 2016 Information Request relating to the former Westinghouse Electric Corporation facility at One Tuscarawas Road in Vanport Township, Beaver County, Pennsylvania ("Site"). Counsel for the Department kindly granted us an extension of until September 30, 2016 to respond to the Information Request.

Response to Requests 1 through 4.

Counsel for the parties have agreed that information previously provided by Westinghouse Electric Corporation to the Department of Environmental Resources concerning the Site satisfies the Department's present Information Request to CBS and that there is no need to respond to the individual requests in the Information Request. The previously provided information includes a letter with attachments from Ms. Linda LeGoullon (Project Engineer, Westinghouse) to Mr. James Shack (Project Officer, DER) dated October 25, 1988 that responded to earlier similar DER requests for information. Counsel for the parties also agreed that CBS may supplement the information previously provided by Westinghouse, which is provided below.


