



Neiswonger Construction, Inc. SMP #63192001, Maggie Lynn Quarry Deemston Borough, Washington County

This request is for the submittal that project consists of a surface boundary of 110.1 acres and an underground boundary of 359.1 acres. This an increase in the size of the permit boundaries of approximately 27 acres. This increase is at the request of the department of environmental protect to include the former Hawkins coal mining permit area on the southeast side of the site. This area has been previously mined and is for the most part barren. The current plans are to use this area for storage of earthern materials.

As has been mentioned previously, the projected lifetime of the project is approximately 30 years. The underground mining will be conducted under at least 100 feet of cover. The surface mining area will include a haul road and areas needed for installation of facilities associated with the underground mining. The surface limestone mining has been ongoing since 2012. The last PNDI that was done for the purposes of the above ground mining was done in August of 2018.

The Maggie Lynn surface Quarry utilizes a block-cut technique, including blasting, to extract up to 40' of Benwood Limestone. The limestone is covered by shale/siltstone, sandstone and soil. Within the 30.3 surface mine, slopes are proposed to be 3.0H to 1V for a depth of 150' except where the existing ground slope is steeper than 3:1. In those areas the backfill will be steeper to tie into the existing slopes. The average length of the backfill will be 500'. The surface mining will cease once the underground mining operation is approved. It is hoped this will occur during the 2024 calendar year. The underground mine will use a room and pillar technique to remove the average 45' thick seem of limestone with maximum ground depth of just over 300'.

A quad map with the location of the underground operation at the end of this narrative. Requests for previous PNDIs have been made dating back over 10 years, as this site is still being used as a limestone surface mine. The most recent requests with a summary listed as follows:

PNDI - 664082 (08/13/2018) - This was done for the 83.4 acres of the above ground permit. At the time this involved a 15.7 acre addition to the above ground permit, which essentially doubled that amount of area to be mined. At the time DCNR had concerns of how to address the Buffalo Clover. This is addressed in a letter from DCNR dated April 10, 2019. The mapping for this PNDI search is given on the following page. It was the last PNDI request made for the above ground mining.


PNDI - 696873 (10/30/2019) - This was the first PNDI done for the underground mine. A narrative called it 325 acres, the majority of which is underground. The PNDI showed a project area of 337.16. A October 31, 2019 letter from DCNR called for "No Impact Expected".

PNDI - 744670 (10/19/2021) - The narrative did not change, it called for 325 acres, the majority of which is underground. The was done as two years had passed since the most recent request. The PNDI area showed 333.48 acres. A July 19, 2022 letter from DCNR called for "No Impact per avoidance, mitigation and monitoring" The letter further discusses that the concerns of the Buffalo Clover are not longer an issue and gives, "Recommended Best Management Practices."

PNDI - 78919 (3/16/2023, updated 10/17/23) - It was an upgrad due to a review letter from the Department of environmental protection. This narrative was consistent with the past underground surface mine permit PNDI searches, calling for 248.8 acres to be mined below ground, 30.3 acres of surface mining and a total of 325 Acres. The drawing with the PNDI showed 335.27 acres. A response was received from DNCR on July 27,2023. This letter specifies no additional surface impacts beyond those of the review of PNDI - 664082. This was the above ground application that showed 30.3 acres of surface mining with a total permit area of 83.4 acres. The above ground mining has stayed within this boundary. As of December 2023. The surface mining is getting close to this extent.

The current PNDI - 804379 (01/12/2024) - This is being done as the project is picking up an additional 26.7 acres. The reasons for this have been given previously.

Thank you for the submission of the Pennsylvania Natural Diversity Inventory (PNDI) Environmental Review Receipt Number 804379 (Final\_1) for review (formerly PNDI Numbers 664082, 696873, 744670, and 781939). PA Department of Conservation and Natural Resources screened this project for potential impacts to species and resources under DCNR's responsibility, which includes plants, terrestrial invertebrates, natural communities, and geologic features only.

#### No Impact Anticipated (with Avoidance Measure)

PNDI records indicate species or resources under DCNR's jurisdiction are located in the vicinity of the project. However, based on the information you submitted concerning the nature of the project, the immediate location, and our detailed resource information, and the Avoidance Measure detailed below, DCNR has determined that no impact is likely. No further coordination with our agency is needed for this project.

Avoidance Measure: A botanical survey conducted by GeoTech Engineering during the 2018 field season documented a population of running buffalo clover (*Trifolium stolonifarum*; PA Endangered; Globally Vulnerable) within the previously proposed surface mining permit area (PNDI 664082). The population was avoided and buffered. Please continue to avoid impacting this location. It is DCNR's understanding that the surface mining permit area along the slopes of Tenmile Creek has not changed since our review of PNDI 664082. Our office does not approve of any additional surface impacts within the Tenmile Creek Valley Natural Heritage Area at this time.

Note: This project impacts the Tenmile Creek Valley Natural Heritage Area, a site of global significance. At this particular location along the slopes of Tenmile Creek, Yellow Oak - Redbud Woodland, an ecological community of concern, provides habitat for running buffalo clover and tall larkspur (Delphinium exaltatum; PA Endangered; Globally Vulnerable). DCNR urges DEP to consider the approval of the proposed underground mine if it will avoid additional surface impacts to remaining woodland along the slopes of Tenmile Creek. Mine reclamation in this area should aim to restore the Yellow Oak - Redbud Woodland community.

#### Recommended Best Management Practices:

 Use a conservative approach to project design that minimizes permanent and temporary disturbances to soil and native vegetation. This will conserve habitat and limit opportunities for invasive plants.
