Hi Gary,

I hope you are doing well. In September and October of 2015, you provided your review of trout classifications on streams crossed by the Sunoco Pennsylvania Pipeline Project (PPP) for the Southwest and Southcentral Regions of PADEP. We have been told by PADEP that some classifications of streams have changed, and both PADEP and Tetra Tech were unsure if your review took into account any upcoming changes for trout classifications. If you would like, I can send you all the letters you provided to us that were addressed to Mike Englehardt and Andy McDonald. PADEP required us to follow up and identify any changes in trout status.

The long and short of all of this is quite a simple question- is the review you completed of those streams in SWRO and SCRO still current and correct?
