HAZARDOUS SITES CLEAN-UP UNDER THE
Response
Mazzaro - McKees Rocks Landfill, Kennedy Township, Allegheny County
Under Section 506(b) of the Hazardous Sites Cleanup Act (HSCA) (35 P.S. § 6020.506(b)), notice is hereby given that the Department of Environmental Protection (Department) has undertaken a HSCA prompt interim response at the Mazzaro - McKees Rocks Landfill site in Kennedy Township, Allegheny County (Site).
Work by DEP and its contractors has demonstrated that landfill gas (LFG), including methane exists within the site and potentially beyond the boundaries of the Site, at levels that exceed standards established in Pennsylvania's Title 25, Chapter 273 regulations for combustible gas monitoring, off-site migration and mitigation at permitted municipal waste landfill sites. The Department has begun a prompt interim response at the Site to help prevent the potential for offsite LFG migration.
The Department has considered the following six alternatives to address the potential for LFG migration from the Site: 1) take no action; 2) installation of an enhanced gas venting system; 3) installation of a passive trench venting system; 4) installation of a semi-active trench venting system; 5) installation of an active trench system; and 6) installation of impermeable barriers.
The Department chose alternative number 3, the installation of a passive trench venting system, because it complies with the applicable or relevant and appropriate requirements and is the most cost-effective.

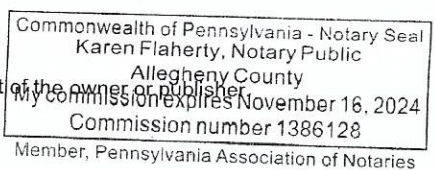
