<u>Project Description</u> - The Pennsylvania Lake Management Society (PALMS) has successfully completed the "Implementation of Lake BMPs Project IV". All three deliverables of this project had met their goals and the accomplishments are listed below

Mini grant program: PALMS had successfully run a mini grant program and was able to award funding of \$374,352.25 to 23 lake BMPS projects. We accepted proposals and ranked them competitively to maximize impact and each project reported reaching its goals.

- 9 of the mini grant projects provided shoreline stabilization and restoration. This included
- 3,860 linear feet of shoreline work. Work also included native vegetation.
- 10 of the mini grant projects focused on or included treatment on 159 acres of lake for infestations of aquatic invasive vegetation.
- 1 project was for stormwater improvements on drainage that leads directly into a lake
- 4 projects were for nutrient reduction and had treatments totaling 90 acres in size
