### 4. First-aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms develop or persist.

Store locked up. Store in corrosive resistant container with a resistant inner liner. Avoid atmospheric exposure. Keep away from flames and sparks. Store away from acids.
